AQR Capital Management, LLC ("AQR")	AQR manages a diversified portfolio of shares listed on stock exchanges predominantly in developed markets, using quantitative analysis to select investments. AQR uses an investment strategy that seeks to capture returns through active stock selection, risk management and diversification.	Founded in 1998, AQR is a U.S. based investment manager with US\$226 billion in assets under management and over 900 staff as at June 2018. Three of the four founding principals previously comprised the senior management of the Quantitative Research Group at Goldman Sachs Asset Management.
LSV Asset Management ("LSV")	LSV manages a concentrated portfolio of global developed and emerging markets stocks using quantitative techniques to select individual securities in a risk-controlled, bottom-up approach.	Formed in 1994, LSV is a quantitative value equity manager providing active management for institutional investors through the application of a proprietary investment model. As at June 2018 it had approximately US\$118 billion in assets under management.
